S. R. O. 150(I)/2004.—In exercise of the powers conferred by section 41 of the Islamabad Wildlife (Protection, Preservation, Conservation and Management) Ordinance, 1979 (LXX of 1979), the Federal Government is pleased to direct the following amendments shall be made in the Islamabad Wildlife (Protection, Preservation, Conservation and Management) Rules, 1983, namely :—

(1) In the rule 2;

After clause (a), the following new clause shall be inserted, namely:—

“(aa) ‘Board’ means the Board of Wildlife Management constituted under section-4”;

(2) after rule 2, the following shall be inserted, namely:—

Composition of the Board, etc.—

“2A (a) The Board shall consist of not more than thirteen members including Minister-in-charge of the C.D.A., Chairman, CDA, Inspector-General of Forests and Wildlife, Ministry of Environment and DG (Environment) CDA who shall be *ex-officio* members and the remaining members, to be appointed by the Federal Government, shall be non-official members.

In connection with the discharge of their responsibilities as Members of the Board, they shall be paid such facilities, allowances and honoraria as the Federal Government may fix”;

(3) In the rule 3;

(a) for clause (i), the following shall be substituted; namely:—

“(i) take all policy decisions, draw plans, programmes and execute them with regard to protection, preservation, conservation and management of wildlife, including the Zoos in the Islamabad Capital Territory”; and

(b) in clause (ii), after the word “Wildlife”, the words “and Zoos” shall be inserted;

(4) In the rule 4;

(a) in clause (i) after the word “approve”, a comma and the words “raise funds” shall be inserted;

(b) in clause (iv) the word “and” at the end, shall be omitted; and

(c) in clause (v) for the full stop, at the end, the semicolon and word and shall be substituted and after clause (v) amended as aforesaid the following new clause shall be added, namely:—

“(vi) appoint such employees, Consultants and experts, as may consider necessary, for the performance of its functions on such terms and conditions as it may deem fit:

Provided that nothing in this rule, or the preceding rule 3, shall empower the Board to dispose of any land or change its in disregard of the regulations of the Authority.”

ORDER

Islamabad, the 10th March, 2004

S. R. O. 151 (I)/2004.—WHEREAS it is expedient to take necessary measures to protect the public morality and the control of illegal trade and smuggling.

NOW, THEREFORE, in pursuance of provisions of Article X of the Agreement between the Government of the Islamic Republic of Pakistan and the Government of Afghanistan for regulation of traffic in transit and in exercise of the powers conferred by sub-section (1) of section 3 of the Imports and Exports (Control) Act, 1950 (XXXIX of 1950) and in supersession of its Notification S. R. O. 11 (I)/2004, dated the 8th January, 2004, the Federal Government pleased to prohibit the bringing into Pakistan by sea, land and air in transit to Afghanistan of goods specified in column (2) of the table below, namely:—
