(I)/2015:- In exercise of the powers conferred by section 41 of the Islamabad Wildlife (Protection, Preservation, Conservation and Management) Ordinance, 1979 (LXX of 1979), the Federal Government is pleased to direct that the following further amendment shall be made in the Islamabad Wildlife (Protection, Preservation, Conservation and Management) Rules, 1983, namely:-

In the aforesaid Rules, in rule 2A, for sub-rule (a) the following shall be substituted, namely:-

- “(a) The Board shall consist of Minister-in-Charge of the Cabinet Division, Mayor of Islamabad Capital Territory Metropolitan Corporation, Chairman, Capital Development Authority, Inspector General of Forest and Wildlife, Ministry of Climate Change, Member (Environment) Capital Development Authority, Secretary, Wildlife Department of Government of the Punjab and Secretary, Environment (Wildlife) Department, Government of Khyber Pakhtunkhwa who shall be *ex-officio* Members and the remaining Members to be appointed by the Federal Government shall be non-official Members.”.
